FOOTPRINT MEAT SURVEY

A trade deal with the US could open up a route to the UK market for meat produced to lower standards. Supermarkets have already committed not to source US meat.

Footprint carried out a survey of leading hotel chains, pub and bar chains, fast food and coffee shop chains and contract caterers to determine:

 a) whether the foodservice and hospitality sector is prepared to source meat from the US; and
 b) current meat sourcing practices.

The following two tables show the results across 25 companies, of which 13 provided information on one or both sets of questions. Those blocked out either did not respond to requests or could not provide the information.

Compass Group UK & Ireland

- Compass Group UK & Ireland is the exclusive user of Oritain in the UK foodservice sector, a pioneering food provenance testing tool.
- All meat is reared in conditions that respect the Five Freedoms.
- Compass Group UK & Ireland has a UK-first sourcing policy which means the majority of what Compass Group UK & Ireland serve is British, with the remainder largely comprising of products which can't be sourced from the UK.
- In July 2019, parent company Compass Group UK & Ireland committed to meet the European Chicken Commitment (ECC) standards for 100% of the chicken meat sourced for Europe by 2026.

Elior

- Elior supports the Five Freedoms, which form the basis of its own animal welfare commitments.
- Elior's consortium for fresh and frozen meat consists of three regional butchers with total UK coverage from trusted and established suppliers. All are EFSIS approved and source Red Tractor UK products for the core meat categories.

KFC

- All UK chickens are Red Tractor certified, and also reared to KFC's Poultry Welfare Policy standard that exceeds Red Tractor. This means that all the farms we source our chickens from have to meet 150 checks and standards before they can supply to our restaurants.
- Signed up to the Better Chicken Commitment; 100% of KFC UK & Ireland's poultry supply is governed by this programme
- It's currently illegal to serve chlorinated chicken in the UK, but if anything were to change, we can confirm that we will not be serving chlorine-treated chicken in our UK and Irish restaurants, as it would be at odds with the stringent standards we've developed.
- KFC's welfare progress report is available here. A new welfare tool has been developed.
